Held under Kennel Club Ltd Rules and Field Trial Regulations

J3d (1) **Open** - A stake in which dogs have the opportunity of gaining a qualification towards the title of Field Trial Champion (K Regulations refer) and towards entry in the Championship or Champion Stake for its breed; in which entry is open to all dogs of a specified breed or breeds, except that such stakes may not be confined to Any Variety Spaniel [except Spaniel (English Springer) and Spaniel (Cocker)]. It may be limited to a prescribed number of runners (J4 refers), in which case these shall be decided by a draw conducted in accordance with Regulation J6i and J6j so that preference is given to previous performance

J3d (2) **All Aged** – A Stake which is open to all dogs of a specified breed or breeds without restriction as to their age, but which may be restricted by any other conditions which may be determined by the society subject to the approval of the General Committee of the Kennel Club

J3d (3) **Novice** - A stake which is confined to dogs which have not gained a place which would qualify them for first preference in the draw for Open stakes

READ THE RULES AND CONDITIONS OF ENTRY CAREFULLY

1. Dogs entered at Kennel Club Licensed Field Trials must be registered at the Kennel Club in accordance with Kennel Club Regulations for Classification and Registration B
2. The Society reserves the right to refuse any entry, except that this shall not apply in terms of preference in the draw. The Kennel Club must be notified in writing of all such refusals with the Society's reason
3. Substitution will be allowed provided the substitute is eligible and is included on the entry form prior to the draw
4. All dogs resident outside the UK must be issued with a Kennel Club Authority to Compete number before entry to the show/event can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor
5. If entries or nominations exceed the number of permitted runners, the right to compete in a Trial shall be decided by ballot
6. Should circumstances so dictate the society, in consultation with the judges, may alter arrangements as necessary. Such changes and the circumstances surrounding them must be reported to the Kennel Club at the earliest opportunity
7. No modification will be made to the schedules except by permission of the Kennel Club, followed by advertisement in appropriate journals, if time permits, before the closing date of entries
8. Judges at a trial are prohibited from entering a dog which is recorded in their ownership or part ownership
9. Videography and photography will only be permitted with the express permission of the Chief Steward and the host
10. Entry forms which are illegible will not be accepted and a separate entry form is required for each dog in each stake entered
11. The draw will take place by FTMS as soon as possible after the closing date of entries and will be organised by the appropriate Field Trial Secretary. All details and directions to the meet will be sent with notification of the draw
12. To qualify for preference in the draw the owner(s) must be fully paid up members. In the event of the society running more than one stake for any one sub-group, an owner offered a run in the first stake will have second preference in the draw for any subsequent similar stake in the same sub-group
13. A handler may only handle one dog per owner unless all reserves have been taken up, however no handler may handle more than two dogs. Only the handler whose name appears on the official entry form may handle the dog on the day
14. A condition of entry to any trial is that competitors indicate their option to accept or withdraw from the trial 7 days prior to the trial date. The club reserves the right to unilaterally remove an entry if this option is not indicated to the Field Trial Secretary
15. All Entries via FTMS or e-mail. Online entries through FTMS must be paid via paypal/online (details on website) 7 days prior to the date of the trial or immediately if offered a run within the last seven days up to the trial date.
16. The society considers that, by accepting a run, owners declare that they have not committed the entered dog to any other stakes on the same dates
17. All persons attending a field trial are under the jurisdiction of the judges and the officers of the society and must conduct themselves accordingly and be appropriately dressed for the day
18. The Society accepts no responsibility for injury, loss or damage to persons or property however occasioned
19. PLEASE NOTE: Loss of arm band £10.00

Dogs in cars on hot days - Your dog is vulnerable and at risk if left in a vehicle in high temperatures and even on days considered as slightly warm. Please take care of your dog. If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused

Welfare of dogs – A competitor whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met and should not knowingly put their dogs' health and welfare at risk by any action, default, omission or otherwise. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any field trial licensed by the Kennel Club. This shall apply at the venue or within the precincts of the trial. A breach of this Regulation may be referred to the General Committee for disciplinary action under Kennel Club Rules and Regulations
